As the Chief Administrative Officer responsible for the firm's build out and move from 399 Park Ave to 7 World Trade Center in NYC and our restack at 60 State Street in Boston, I had the pleasure of collaborating with Elizabeth Erdreich White and her firm, Erdreich White Fine Art (EWFA), over the past 3 years. Our scope involved an extreme shift in both our addresses and environment. Both spaces were designed to be forward thinking, quite modern yet classic. In fact, 2 major motion pictures have been shot in our space, both of which asked her permission to include the art.
